

Ráðstefna um gæðamál á háskólastigi verður haldin í hátíðarsal Háskóla Íslands, 16. – 17. apríl næstkomandi. Starfsmenn menntamálaráðuneytis eru sérstaklega hvattir til að skrá sig og mæta.

Á ráðstefnunni verða fimm málstofur um mál sem eru í deiglunni varðandi gæði skólastarfs á háskólastigi á norðurlöndunum. Er ein málstofa tileinkuð samnorrænu meistaraþrófnámi sem komið var á fót með styrk Norrænu ráðherranefndarinnar. Samtök Norrænna gæðaeftirlitsstofnanna, NOQA hafa haft umsjón með ytra mati á þessum verkefnum undanfarið ár. Þá er ein málstofa sérstaklega tileinkuð viðmiðum um hæfni (Learning Outcomes) og hvernig hægt sé að nýta sér þau í innra og ytra gæðamati. Þá verður fjallað um úttektir á sjálfsmatskerfum háskóla á Norðurlöndum og ein málstofa mun taka til umræðu hvort Norðurlöndin séu til fyrirmyndar hvað varðar gæðamál og hvaða áhrif aukið flæði nemenda á milli skóla og gagnkvæm viðurkenning á námi milli háskóla muni hafa á gæði og gæðaeftirlit. Ráðstefnunni lýkur svo með pallborðsumræðum um hvort æskilegt sé að gera Norðurlöndin að einu sameiginlegu gæðaeftirlitssvæði.

Katrín Jakobsdóttir menntamálaráðherra mun setja ráðstefnuna. Meðal fyrirlesara má finna Norman Sharp, yfirmann QAA og alls gæðaeftirlits á háskólastigi í Skotlandi, Josep Grifol frá Spáni sem hefur verið framarlega í skipulagningu á samstarfi Evrópuþjóða á sviði gæðastarfs og Iréne Häggström, gæðastjóra Karolinska Institut sem er samkvæmt alþjóðlegum mælingum talinn besti háskólinn á Norðurlöndum. Auk þess taka allir helstu yfirmenn gæðaeftirlits háskóla í Finnlandi þátt í ráðstefnunni.

Joint masters programmes between higher education institutions in the Nordic countries have existed only for a relatively short time, but it is not until recently that a special attention

has been paid to them in a national or supranational context. This development creates a general need for both HE institutions, QA agencies and governments for a common Nordic way to ensure the quality of these joint degree programmes as a whole and not only as detached parts offered in different countries that at the same time satisfy local legislative framework and ensures pan-Nordic legitimacy.

13.15 – 17.00 Quality assurance of Higher Education in a Globalized World – The Nordic countries as the good example?

Higher Education Institutions are responsible for developing and offering world-class education. The institutions are also responsible for establishing mechanisms for controlling the quality of the education. A global market for higher education poses increased demands on transparency, demands the individual institutions can not meet on their own. There is therefore a need to develop transparent instruments that document the quality of the degrees offered by each institution but there is also an increased demand for an international acceptance of quality assurance. This need could be met by internationally based quality assurance followed by automatic international or regional accreditation. Automatic accreditation could be based on quality assurance conducted by any internationally recognised quality assurance agency. The aim of the session is to discuss areas where there is a need for international accreditation and where the Nordic countries could take a lead.
